## **Administrator's Message**

On September 8, 2015, we opened our school doors, celebrating our 16th year as CLS, and greeted 93 students for the current school year. We welcomed 17 new students and 8 new staff members, and many of our returning students, families, and staff. Fine arts classes this year include art, music and theater. In addition, we continue our CLS before-and-after-care program to support our families who need that service.

Our CLS rigorous, faith-based educational program is evident throughout our building. Students are engaged in lessons that require them to think, problem solve and to be creative. Subjects taught include opportunities for students to show what they know and are able to do in a variety of ways. The environment is one of mutual respect — and we celebrate Christian Compassion, demonstrate a love of learning and develop social responsibility! Chapel services take place each Wednesday and visitors are always welcome to attend. CLS encourages families and community members to volunteer in our wonderful place of learning where the love of Christ is proclaimed through the integration of faith and life.

## FTT Tresident's Message

The Family Partnership Program (FPP) was formed to foster communication between parents and teachers as well as provide mutual support and assistance to improve the learning experience and lives of our children. The FPP also serves as a direct voice to both the CLS administration and the Board of Trustees. All parents of children at Carroll Lutheran School are automatically members of the organization and are strongly encouraged to join with your school's other families, parents and children at our monthly meetings and awesome events. We welcome everyone and welcome you to our community!

The simple truth is that exceptional education requires resources. We could talk about the nearly \$50,000 that the FPP raised in the 2014-2015 school year, but that is only part of the story. Some of the awesome things we did with that money included providing refreshments for various events, purchasing name badges, having great times at places like Players and Magic Elm Skateland, and adding funding to the school's scholarship program. One of the largest recent contributions to the school was in technology, including the replacement of the old WiFi system with a new, highly secure and stable platform; providing a huge boost to the CLS technology plan with the purchase of 30 brand new Chromebooks for teachers and students; and protecting our children with internet filters. These are just a few examples of how those funds help drive the exceptional education and community that is unique to CLS.

## Grants

### Lutheran Home and Hospital Foundation

In 2013, Carroll Lutheran School received a \$100,000 grant from the *Lutheran Home and Hospital Foundation* for the development of a school-wide wellness program including health education and guidance. The grant, to be used over a 3-year period, has provided the CLS Community with a part-time guidance counselor, a part-time health educator, and has expanded the role of the school's delegating nurse. Having ended our second year of implementation, CLS has a health curriculum in place for grades kindergarten through grade 8. In addition, the guidance counselor provides in-class guidance lessons as well as individual and small group counseling sessions. This grant has enabled CLS to address our students' social/interpersonal well-being, emotional well-being and physical well-being, while our school program continues to strengthen our students' intellectual and spiritual well-being. Martin Luther said "This life, therefore, is not godliness but the process of becoming godly, not health but getting well, not being but becoming, not rest but exercise. We are not what we shall be but we are on the way."
